Location Fees – Cost may increase if service location exceeds 20-mile radius of salon.

Holiday Weddings – The \$100 fee will be charged for the following holidays: Thanksgiving, Christmas/Eve, and New Year’s Day

Before or After Hours Show Time – A \$100 fee is applicable when the stylist is required to arrive before 7:00am or after 5:00pm on the day of your event.

Contract Details

This contract requires a 50% non-refundable retainer and secured with credit card information to reserve your date and schedule appointments. The remaining balance will be due on the day of the wedding paid with cash or check. Should there be a need to adjust or cancel any appointments, we ask that all changes and/or cancellations be made 14 days prior to the wedding date. If after the event there are any unpaid balances, it will be charged to the credit card on file.

Cancellation Policy

- 14 or more before event: deposit forfeited but no additional charges
- Less than 14 days before event: full amount of services booked will be charged
- No Show/Missed Appointments: full amount of service will be charged
