Contract Details

This contract requires a \$150 non-refundable retainer and secured with credit card information to reserve your date. There is a 50% required payment required 4 weeks before the event with the remaining balance due seven (7) days prior to the event date. Acceptable payment methods are cash, Venmo (latashabrown843), credit card, check, or online via electronic invoice.

Gratuity

- We include a service gratuity of 20% to invoicing. This helps to simplify the transaction process since the wedding day can be hectic and stressful. Past brides have expressed that this is helpful in reducing stress and saving time on the day of.

Cancellation Policy

- Any cancellations must be done 6 weeks or more before event or payment for cancelled services will be due in full.
- If a stylist cancels or is unable to perform duties for any reason, 110% of the retainer will be refunded within two (2) weeks. Client agrees that the refund of 110% of the retainer is the only liability of Juve Salon Studio, employees, and agents.

Location Fees

- Applies if service location is outside of Charleston Peninsula/Mount Pleasant (over 15 mile radius from studio)

Holiday Weddings

- The \$100 fee will be charged for the following holidays: Thanksgiving, Christmas/Eve, and New Year's Day

Before or After Hours Show Time

- A \$100 fee is applicable when the stylist is required to arrive before 7:00am or after 4:00pm on the day of your event.

Liability

- All brushes and makeup products are kept sanitary and are sanitized between every makeup application. All makeup products are hypoallergenic. The client should disclose any skin conditions or allergies to the makeup artist prior to makeup application. Client(s) agree to release makeup artist, Juve Salon Studio, and all employees and agents from liability for any such skin complications due to allergic reactions.

BEFORE SIGNING THIS CONTRACT, PLEASE BE SURE TO READ OVER EACH CLAUSE AS THIS IS A LEGALLY BINDING CONTRACT



I agree to the terms and conditions outlined in this contract as applicable to my scheduled appointments. I agree to have my appointments scheduled, the prices, and policies listed in this contract. I understand and agree to the \$150 non-refundable retainer required to secure appointments for my bridal party. I agree to pay the complete balance for my event on the date specified in this contract. I understand and will comply with the cancellation policy. I understand that no refund will be given for members of the scheduled event who miss their appointments of the day of the event. I also understand that I am responsible for the balances from any members of my party who fail to provide payment. The total cost incurred by the bridal party is the responsibility of the undersigned, and I understand that if a member of the bridal party fails to pay for any service, I am responsible for the payment.
